ENTRY PACKET CHECKLIST

One set of prints or color copies of your finished project. The photographs should represent a minimum of three interior spaces and a maximum of eight. Print size should be at least 3" x 5". Varied print sizes of your project are acceptable. Names of designers should not appear on any photographs. **Photographs will not be returned.**

A typed page describing the project's scope—location, style, inspiration, client's requirements, square footage, layout/floor plan (written or illustrated), approximate budget, challenges, and unique features.

Complete permission section from the homeowner stating that the project may be entered, and possibly published, by Utah Style & Design magazine. (Entries without the signed permission form from the homeowner will be disqualified.)

Open to all Interior Designers. To enter, mail entry and permission form with packet requirements to Utah Style & Design/Brad Mee, 240 Morris Avenue, Suite 350, Salt Lake, Utah 84115. Or visit our web site at www.utahstyleanddesign.com to download an entry form. One project entry per envelope. There is no limit on the number of entries per person. Mailed entries must be postmarked by June 1, 2006. Entries must be submitted by the interior designer on the project and must be the work of that interior designer. **Homeowner must consent to entry.** Photographs will become the property of Utah Style & Design and will not be returned. A team of photography, design, and editorial professionals will judge the entries on originality, visual impact, livability, creative use of materials and furnishings, and skillful execution of design principles. Project must still exist as it appears in entry photographs. Judging will occur during the week of **June 1, 2006**. Judges' decisions are final. The winning project will be professionally photographed by Scot Zimmerman and published in Utah Style & Design magazine or featured on its web site. Submitted projects must be located within Utah, southern Idaho, or western Wyoming.
